- glass –no molds or other forms of mass production
- painting- oils, acrylics, etc.
- photography- all photos must be taken by artist
- sculpture- dimensional work done in any mediums will be considered.
- watercolor- layered and pigmented water-based media including acrylic, gouache, tempera and transparent watercolors applied to archival stock or handmade papers.
- woodwork- original hand tooled, machine worked or carved work.
- metalwork- all hand-made metal work will be considered
- jewelry- must be handmade and no commercial or production work will be considered or accepted.
- drawing_ pencil, charcoal, chalk, pastels, etc.
- fiber- handcrafted fiber, straw, leather, or similar materials. No mass produced materials will be accepted. No sports related fabrics will be accepted (examples: raiders or 49ers).
- functional art- 3-d creations. Furniture, wind chimes, dinnerware, lamps, etc.
- bath and body products- handmade soaps, bath products, facial care, etc. Must be handmade, no mass produced.
